If the marks so works out are in fraction, the same shall be raised to the next higher whole number.
- A candidate who clears an option/ core subject and practical as due subject shall be deemed to have secured the minimum pass marks prescribed for that subject/practical for purpose of determining division at the Sayukt Acharya Semester Examination and for admission to the next higher class.

- Classification: First Division 60%, Second Division 45% and Pass class 35% in the total aggregate.
- For a pass in examination, a candidate is required to obtain at least 25% marks in each paper and 36% marks in the total aggregate in Theory at the every semester Examination separately and 36% marks in practicals separately, Wherever prescribed.
- (a) A candidate who has failed at Acharya III & IV semester Examination but has passed in atleast 50% of the papers prescribed for the examination obtaining 25% Marks in each paper in accordance with the rules given below shall be eligible to reappear in the failing papers of Semester III&IV alongwith the Final Examination.
- (b) A candidate who has failed at the Acharya III&IV examination but has passed in atleast 50% of the papers obtaining 25% marks in each paper prescribed for the examination in accordance with the rules given in the clause below shall be exempted from re-appearing in a subsequent year in the papers in which he has passed.

- (d) For securing 50% of the papers at the Semester Examination, Practical will be included and one practical will be counted as one paper.
- (e) If the number of papers prescribed for the Semester Examination is an odd number it shall be increased by one for the purpose of rounding 50% of the papers.
- (f) A candidate who does not pass even in 50% of the papers prescribed for the Acharya Semester examination in accordance with the above rules shall not be eligible for admission to the next Acharya Semester Class. He will be required to re-appear at the failed Semester examination in all the prescribed papers and practicals.
- (g) A candidate who does not pass even in 50% of the papers prescribed for the Acharya III & IV Semester Examination in accordance with the above rules shall be required to re-appear at the same in subsequent Part-II examination in all the prescribed papers and practicals.
- (h) If a candidate covers any paper (a) practical (a) dissertation viva-voce prescribed at the Part-I and/ or Part-II Examination separately after a continuous period of three years, for the purpose of working out his division, only the minimum pass marks viz. 25% (36% in case of Practical) shall be taken into account in respect of each paper (a) practical/dissertation as are cleared after the aforesaid period provided that in case where a candidate requires more than 25% marks in order to reach in requisite minimum aggregate as many marks out of those actually secured by him will be taken into account as would enable him to make up the deficiency in the requisite minimum aggregate.

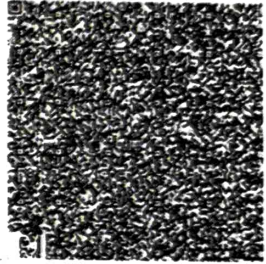
